

"Now, therefore, with the consent of the said Mary Elizabeth Dalton, Emily Marian Dalton, and Frederick William Dalton, (in testimony whereof they have signed and sealed this Scheme), and with the consent of the said Frank Theodore, Bishop of Peterborough, (in testimony whereof he has signed this Scheme, and sealed the same with his Episcopal Seal), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Seagrave, now vested in them the said Mary Elizabeth Dalton, Emily Marian Dalton, and Frederick William Dalton, as aforesaid, shall be transferred to the said Frank Theodore, Bishop of Peterborough, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Frank Theodore, Bishop of Peterborough, and his Successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Peterborough.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 2nd day of May, 1918, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd

and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (herein-after called 'the said Benefice') of Crundale, in the County of Kent, and in the Diocese of Canterbury:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Crundale is vested for an estate in fee simple, free from incumbrances, in certain Trustees upon trust in the first place for Arthur Thomas Wilson Filmer, a Lieutenant of Your Majesty's Horse Guards, and the said Arthur Thomas Wilson Filmer is therefore the Patron or person entitled to nominate to the said Benefice in case the same were now vacant:

"And whereas the said Arthur Thomas Wilson Filmer is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Crundale should be transferred to and be vested in the Right Honourable and Most Reverend Randall Thomas, now Archbishop of Canterbury, and his Successors in the same Archbishopric:

"And whereas the said Randall Thomas, Archbishop of Canterbury, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Randall Thomas, Archbishop of Canterbury, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Crundale, which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Parish of Crundale.

"Now, therefore, with the consent of the said Arthur Thomas Wilson Filmer, being the person whose consent as Patron is required by the provisions of the hereinbefore mentioned Acts, and of the Act of the 1st and 2nd years of Her said late Majesty Queen Victoria, Chapter 106, (in testimony of which consent he has signed and sealed this Scheme), and with the consent of the said Randall Thomas, Archbishop of Canterbury, (in testimony whereof he has signed this Scheme, and sealed the same with his Archiepiscopal Seal), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said benefice of Crundale shall be transferred to
