The Civil Service Commissioners hereby give notice that an Open Competitive Examination of Candidates for registration as Temporary Boy Clerks will be held in London, Edinburgh, Dublin, Cardiff, Leeds, Liverpool, Plymouth, Portsmouth, Belfast and Cork, commencing on the 1st October, 1918, under the Regulations dated the 15th September, 1916, as amended the 12th March, 1918, and published in the London Gazette of those dates.

The number to be registered will depend partly on the requirements of the service, and partly on the number of candidates who may show sufficient proficiency; but it is not likely to be less than 200 for service in London, if so many shall be found competent.

No candidate will be admitted to the Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 29th August, an application, on a

prescribed form, which may be obtained from the Secretary at once.

NATIONAL INSURANCE (HEALTH)  
ACTS, 1911 to 1918.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee acting jointly with the Insurance Commissioners, the Scottish Insurance Commissioners, the Irish Insurance Commissioners, and the Welsh Insurance Commissioners, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by the National Insurance (Health) Acts, 1911 to 1918, and by the National Insurance (Joint Committee) Regulations, 1912 to 1918, to make regulations with respect to—

(1) the granting of Certificates of Exemption to persons resident in Ireland, not being Irish migratory labourers within the meaning of Section 81 (3) of the National Insurance Act, 1911;

(2) the benefits of persons to whom such certificates are granted;

and by such regulations to revoke (save as is expressly provided in Article 4 thereof) the National Health Insurance (Exempt Persons) Consolidated Regulations (Ireland), 1916.
