Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us, and it appears to us to be expedient, that the boundaries of the said New Parish of Saint Mary, Bilston, should be altered in the manner which is herein-after mentioned:

"Now, therefore, with the consent of the Right Reverend John Augustine, Bishop of Lichfield, (in testimony whereof he has signed and sealed this Scheme or Representation), We, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Mary, Bilston, shall be altered so that all that portion of the Parochial Chapelry of Bilston, in the said County and Diocese, which is described in the Schedule hereunder written, and is delineated and set forth upon the Map or Plan hereunto annexed, and is thereon coloured pink, shall be dissevered from such Parochial Chapelry, and shall be annexed to and shall in future form part of the said New Parish of Saint Mary, Bilston.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, or proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the herein-before-mentioned Acts, or of any of them, or of any other Act of Parliament.

"The SCHEDULE to which the foregoing SCHEME or REPRESENTATION has reference.

"The territory to be annexed to the New Parish of Saint Mary, Bilston, in the County of Stafford, and in the Diocese of Lichfield,

being:-

"All that portion of the Parochial Chapelry of Bilston, in the said County and Diocese, which is bounded upon the south by the said New Parish of Saint Mary, Bilston, and upon the remaining sides, that is to say, upon the west, upon the north-west, and upon the northeast, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Saint Mary, Bilston, from the said Parochial Chapelry of Bilston crosses the middle of Oxford Street, and extending thence north-westward along the middle of Oxford Street for a distance of 1 chain or thereabouts to its junction with Queen Street, and extending thence north-eastward along the middle of Queen Street for a distance of 33 chains or thereabouts to its junction with Bridge Street, and extending thence northwestward along the middle of Bridge Street for a distance of 8 chains or thereabouts to its junction with Fraser Street, and extendnorth-eastward ing thence along the middle of Fraser Street for a distance of 12 chains or thereabouts to its junction with Ashley Street, and extending thence southeastward along the middle of Ashley Street for a distance of 7½ chains or thereabouts to its junction with Queen Street, and continuing thence south-eastward in precisely the same direction and in a straight line for a distance of 7 chains or thereabouts to a point in the middle of Bilston Brook upon the boundary which divides the said Parochial Chapelry of Bilston from the said New Parish of Saint Mary, Bilston."

And whereas Drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation, and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lichfield.
