"Now, therefore, with the consent of the Right Reverend Thomas Wortley, Bishop of Ripon, (in testimony whereof he has signed and sealed this Scheme or Representation), We, the said Ecclesiastical Commissioners, humbly represent, recommend, and propose, that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation, and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint-Cuthbert, Forcett, shall be altered so that all those portions of the Parish of Melsonby, of the Parish of Stanwick, and of the Parish of Kirkby Ravensworth, all in the said County and Diocese, which are described in the Schedule hereunder written, and are delineated and set forth upon the Map or Plan hereunto annexed, and are thereon coloured pink, shall be dissevered from such Parishes, and shall be annexed to and shall in future form part of the said New Parish of Saint Cuthbert, Forcett.

"And we further represent, recommend, and propose, that nothing herein contained shall prevent us from representing, recommending, or proposing, any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the herein-before mentioned Acts, or of any of them, or of any other Act of Parliament.

"The SCHEDULE to which the foregoing SCHEME OF REPRESENTATION has reference.

"The territory to be annexed to the New Parish of Saint Cuthbert, Forcett, in the County of York, and in the Diocese of Ripon, being:—

"1. All those detached portions of the Parish of Melsonby, and of the Parish of Stanwick, both in the said County and Diocese, which are comprised within, and are co-extensive with, the Civil Parish of East Layton:

"2. And also all that portion of the Parish of Kirkby Ravensworth, in the said County and Diocese, which is bounded upon the east, upon the north, and upon the west, by the above-mentioned detached portion of the Parish of Melsonby, and upon the remaining side, that is to say, upon the south-west, by an imaginary line commencing at the point where the boundary which divides the said detached portion of the Parish of Melsonby from the said Parish of Kirkby Ravensworth meets the northern side of the road called Watling Street (leading from Barnard Castle to Catterick) almost opposite to the public house called Fox Hall, and extending thence first southward to, and then south-eastward along, the middle of the said road for a distance of 46 chains or thereabouts to the boundary which divides the said Parish of Kirkby Ravensworth from the said detached portion of the Parish of Melsonby.''

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of Ripon.
