THE HOUSEHOLD COAL (REQUISITION) ORDER, 1918, DATED 7TH DAY OF SEPTEMBER, 1918, MADE BY THE BOARD OF TRADE UNDER REGU-LATIONS 2F AND 2JJ OF THE DEFENCE OF THE REALM REGULATIONS.

The Board of Trade, deeming it expedient to make further exercise of their powers under the Defence of the Realm Regulations as respects coal, hereby Order as follows:

1. All persons owning or having power to sell or dispose of coal to which the Household Fuel and Lighting Order, 1918, applies and which has been or is being consigned in truck loads to consumers are hereby required to hold such coal at the disposal of the Board of Trade and to deliver it if and when required to the Local Fuel Overseer for the area in which such coal may be.

2. The compensation to be paid for any · coal so requisitioned shall be determined in default of agreement by a single arbitrator appointed by the Controller of Coal Mines.

This Order may be cited as the Household Coal (Requisition) Order, 1918.
