"And whereas the said Ralph Paget is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Sutton Waldron, now vested in him as aforesaid, should be transferred to and be vested in the Right Reverend Frederic Edward, now Bishop of Salisbury, and his Successors in the same Bishopric: "And whereas the said Frederic Edward,

"And whereas the said Frederic Edward, Bishop of Salisbury, is willing to accept such transfer, and in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the Diocese which, by the Acts in the hereinbefore mentioned Act recited, or by some or one of them, is made necessary, he, the said Frederic Edward, Bishop of Salisbury, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Sutton Waldron, which is hereinbefore mentioned, and hereinafter recommended and proposed, will, in our opinion, tend to make better provision for the Cure of Souls in the Parish or District in or in respect of which the right of Patronage or Advowson, so recommended and proposed to be transferred as aforesaid, arises or exists, that is to say, in the Parish of Sutton Waldron:

"Now, therefore, with the consent of the said Ralph Paget (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Frederic Edward, Bishop of Salisbury, (in testimony whereof he has signed this scheme, and sealed the same with his Episcopal Seal), We, the said Eccle-

siastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publiupon and cation in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Sutton Waldron, now vested in him the said Ralph Paget as aforesaid, shall be transferred to the said Frederic Edward, Bishop of Salisbury, and his Successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in, and shall and may from time to time be exercised by, the said Frederic Edward, Bishop of Salisbury, and his Successors in the same Bishopric for ever.
