

Civil Service Commission,

The Civil Service Commissioners hereby give notice, that an Open Competitive Examination will be held in London, on the 28th November, 1918, under the Regulations dated the 19th March, 1918, and published in the London Gazette of the same date, relating to the following situation, viz. :—

Female Sorting Assistant in the General Post Office, London, and in the General Register Office, London.

Appointments will be offered to not fewer than 60 of the Candidates highest on the list, provided they obtain the necessary aggregate of marks and are duly qualified in other respects.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 31st October, an application on the prescribed form, which may be obtained from the Secretary at once.

PROVISIONAL REGULATIONS UNDER THE ABOVE-MENTIONED ACTS.

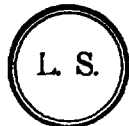
The Board of Agriculture and Fisheries, in exercise of the powers conferred on them by the above-mentioned Acts, do hereby order as follows :—

1. An Award in an arbitration under Part IV. of the Corn Production Act, 1917, as amended by the Corn Production (Amendment) Act, 1918, shall be in the form set forth in the Schedule hereto or to the like effect.

2. These Rules extend to England and Wales only.

3. The Board hereby certify that on account of urgency these rules should come into immediate operation, and direct that they should operate accordingly as provisional rules.

Whereas C.D., of
a person interested in the above mentioned holding, duly made a claim for compensation to be paid by the Board of Agriculture and Fisheries (hereinafter referred to as "the Board") in respect of loss claimed to have been suffered by the said C.D. by reason of the exercise of the powers of the Board in manner described in the Schedule hereto.

And whereas C.D., and the Board, have failed to agree as to the amount and time and mode of payment of the compensation to which the said C.D. so claims to be entitled.

And whereas by an appointment in writing, dated the

, and made by (or on behalf of) the Board and the said C.D. (or by the President of the Surveyors' Institution), I, the said A.B., was duly appointed under the said Acts, to act as arbitrator for the purpose of settling the said differences (questions and claims) in accordance with the provisions set out in the Second Schedule to the Agricultural Holdings Act, 1908.

And whereas application has been duly made to me to specify the amount awarded in respect of such of the claims set forth in the said Schedule as are therein marked with an asterisk.

(And whereas the time for making my Award has been extended by the Board of Agriculture and Fisheries to the

Now know ye that I, the said A.B., having taken upon myself the burden of the said reference, and having heard, examined, and considered the witnesses and evidence concerning the said matters so referred to me as aforesaid, do make and publish this my Award of and concerning the same in manner following, that is to say :—

1. I award and determine that the said C.D. is entitled to receive from the Board as compensation in respect of loss suffered by the said C.D. by reason of the exercise of the powers of the Board in manner described in the Schedule hereto the sum of

2. I hereby declare that the amounts awarded by me in respect of such of the said claims as are marked with an asterisk are the amounts set against such claims in such Schedule.

3. I award and determine that the said sum of

pence awarded by me shall, subject to the provisions of the Agricultural Holdings Act, 1908, be paid by the Board to the said C.D. on the *
