Notwithstanding anything in the Wool and Tops (Dealings) Order, 1917, as amended by the Wool and Tops (Dealings) (Amendment) Order, 1917, the Crossbred or Merino Wool (Maximum Prices) Order, 1917, and The Merino Tops (Delivery) Order, 1917, dealings in South African Wool and in Tops produced therefrom are authorised and permitted without restriction.

2. This Order may be cited as the South African Wool and Tops Permit, 1919.
