#### BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Davis Bernstein.

Revocation of Certificate of Naturalization.

Whereas I am satisfied that Davis Bernstein, to whom a Certificate of Naturalization numbered 11304 was granted on the 30th January, 1900, pursuant to the provisions of the

Naturalization Act, 1870, has shown himself by act to be disloyal to His Majesty

Now, therefore, by this Order made in pursuance of the powers conferred upon me by Section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the said certificate and I direct such revocation to have effect from the date hereof.
