**DEFENCE OF THE REALM (LIQUOR CONTROL).**

**ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE WESTERN BORDER AREA.**

We, the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following Order:—

1. Such of the provisions of Article 2 of the Order of the Board made on the 11th day of November, 1915, for the Western Border Area, as amended by subsequent Orders of the Board made respectively on the 1st day of December, 1915, the 21st day of December, 1916, and the 30th day of May, 1917, as prohibit the sale and supply of intoxicating liquor in licensed premises and clubs on Sundays, shall cease to
