have effect in so far as they apply to any part of the area situate in England: and the said Article shall be amended by striking out from paragraph (1) (a) thereof all the words from the words "the City of Carlisle" to the words "in the County of Cumberland" inclusive and shall be read and have effect as if amended accordingly.

2. The Order of the Board made on the 16th day of February, 1917 (prohibiting the sale and supply of spirits to be consumed on the premises in licensed premises and clubs in certain parts of the area on Saturdays), is hereby revoked in so far as it applies to any part of the area situate in England.

3. This Order shall come into force on the
