under any prohibition of export or prohibition of import for the time being in force in the United Kingdom, or in respect of any remittance of money out of the United Kingdom covered by Regulation 41D of the Defence of the Realm Regulations, is first obtained:

Provided also that this licence shall not permit any person or body of persons to pay to any person or body of persons resident or carrying on business in Czecho-Slovakia any sum of money which by the terms of the Trading with the Enemy Amendment Acts, 1914 and 1915, or either of them, is required to be paid to the Custodian appointed under the Trading with the Enemy Amendment Act, 1914, but such sums of money must be paid to the said Custodian:

Provided further that this licence shall not permit any person or body of persons to pay or deliver to any person or body of persons resident or carrying on business in Czecho-Slovakia any sum of money or property of which prior to the date hereof notice has been or ought to have been given to the said Custodian under the said Acts or either of them.
