

tion to the raising of money by borrowing or by the creation and issue of debenture stock shall not be reduced or liable to reduction by reason of the creation of any rent charge the acquisition of lands in consideration of a rent charge or any payment or making up of dividends or payment of interest out of capital under the powers of the Act of 1913 or the intended Act.

18. To authorize the Company or their directors to raise for the general purposes of the Company further monies by the creation and issue of new shares or stock (redeemable or irredeemable) with or without preference or guaranteed dividend or other rights and privileges and by borrowing and by the creation and issue of debenture stock or any of such means and in such manner as the Company or their directors may deem most advantageous, to empower the Company and the London Electric Railway Company to apply any capital or funds now belonging to or hereafter to belong to them respectively or under their respective controls to the purposes of the intended Act and to the general purposes of the undertaking of the Company and to enter into agreements with reference thereto and to authorize the application of any such capital or funds of the Company towards providing for loss on sale of rolling stock, motors, machinery and plant and to remove any limitations on the amount of any dividends or of interest which the Company may pay on any existing or authorized capital on debentures or debenture stock of the Company.

19. To alter or fix the quorum for general meetings of the Company and the rights of voting of holders of shares and stock in the capital of the Company.

20. To vary and extinguish all rights and privileges which would or might interfere with any of the objects of the intended Act and to confer other rights and privileges.

21. To alter amend extend enlarge and repeal the provisions of the City and South London Railway Acts 1884 to 1913 and all other Acts relating to the Company.

And notice is hereby further given that on or before the 15th day of March 1919 plans and sections of the works proposed to be authorized by the intended Act showing the lines and levels thereof and plans showing also the lands and property to be purchased or acquired compulsorily under the powers of the intended Act with a book of reference to such plans and a copy of this Notice as published in the London Gazette will be deposited for public inspection with the Clerk of the Peace for the County of London at his office at the Session House, Clerkenwell Green, E.C., and with the Town Clerks of the Metropolitan Boroughs of St. Pancras, Finsbury, Lambeth and Wandsworth at their respective offices.

Printed copies of the intended Act will be deposited in the Private Bill Office of the House of Commons on or before the 31st day of March next.
