

in possession with divers remainders over, and the said Indenture of the 9th day of October, 1882, contains a power of sale and exchange now exercisable by Geoffrey Egerton Warburton, a Major in Your Majesty's Army, D.S.O., Montague Rhodes James, Provost of Eton College, and the Honourable Archibald Campbell McGarel-Hogg with the consent in writing of the said Jane Anne, Lady de Saumarez:

"And whereas it has been proposed to us that the Patronage of the said two Benefices of Saint Mary, Woolnoth, with Saint Mary, Woolchurch Haw, and Sudbourne with Orford may be rearranged, by way of exchange, in the manner which is hereinafter recommended and proposed:

"And whereas we have made due enquiry and calculation as to the circumstances and relative values of the said two Benefices and of the Patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two Benefices are as set forth in the Schedule hereunto annexed:

"And whereas the clear yearly value in Your Majesty's Books of the Benefice of Saint Mary, Woolnoth, is £25, of the Benefice of Saint Mary, Woolchurch Haw, is £18 13s. 4d. and of the Benefice of Sudbourne with Orford is £33 6s. 8d.:

"Now, therefore, with the consents of the said Jane Anne, Lady de Saumarez, Geoffrey Egerton Warburton, Montague Rhodes James and Archibald Campbell McGarel-Hogg, in respect to the moiety of the Advowson or perpetual right of Patronage of the said Benefice of Saint Mary, Woolnoth, with Saint Mary, Woolchurch Haw, standing limited to uses as aforesaid, pursuant to the said Indenture of the 9th day of October, 1882, and with the consent of the Right Honourable David Lloyd George, now First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty as the Patron of the said Benefice of Sudbourne with Orford, (in testimony whereof they have signed and sealed this Scheme), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law

other than such duly gazetted Order, the moiety of the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Mary, Woolnoth, with Saint Mary, Woolchurch Haw, and the Church thereof now standing limited to such uses as aforesaid under which the said Jane Anne, Lady de Saumarez is tenant for life in possession thereof as aforesaid shall be assigned and transferred to and shall thereupon and thenceforth belong to Your Majesty, Your Heirs and Successors, and such right of Patronage so transferred may from time to time and at all times be exercised by the said David Lloyd George or other the First Lord of Your Majesty's Treasury for the time being on behalf of Your Majesty, Your Heirs and Successors, in such manner that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Mary, Woolnoth, with Saint Mary, Woolchurch Haw, shall thereafter belong to Your Majesty, Your Heirs and Successors, and that in exchange for the same the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Sudbourne with Orford and the Church thereof shall in like manner and upon and from the same date be assigned and transferred from Your Majesty, Your Heirs and Successors, and shall thereupon and thenceforth become and be absolutely vested in the said Geoffrey Egerton Warburton, Montague Rhodes James and Archibald Campbell McGarel-Hogg and their heirs To hold to such of the uses upon such of the trusts and with and subject to such of the powers provisoes agreements and declarations in and by the said Indenture of the 9th day of October, 1882, limited expressed and declared of and concerning the said Advowson donation and right of Patronage of and in the said Benefice of Saint Mary, Woolnoth, with Saint Mary, Woolchurch Haw, as immediately before the publication in the London Gazette of such Order as aforesaid shall be subsisting or capable of taking effect.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.
