## LONDON, MIDDLESEX AND DISTRICT (MUZZLING AND CONTROL OF DOGS) ORDER OF 1919 (No. 6).

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:.

1. The London, Middlesex and District (Muzzling and Control of Dogs) Order of 1919 (No. 2) shall be read and have effect as if the Area described in the Schedule hereto were included in and formed part of the Area to which that Order applies as described in the Schedule to the London, Middlesex and District (Muzzling and Control of Dogs) Order of 1919 (No. 4) and extended by the London, Middlesex and District (Muzzling and Control of Dogs) Order of 1919 (No. 5).

2. This Order shall come into operation on the fifteenth day of July, nineteen hundred and nineteen.
