The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:-

The provisions of the Monmouthshire and District (Control of Dogs) Order of 1919 (No. 5) shall not apply to any movement in connection with hunting of the Wye Valley Otterhounds kept at Ross-on-Wye, in the county of Erreford, or to the hounds while being so moved: Provided that the hunting shall be confined to the petty sessional divisions of Ross and Harewood End, in the administrative county of Hereford, and to the county of Brecknock (except the petty sessional divisions of Crick-howell and Brynmawr and the parishes of Llanddetty, Vaynor, and Penderyn), and provided also that the movement of the hounds for such purpose from Ross-on-Wye to Brecknockshire and back again shall be effected as far as practicable by railway, and that the hounds shall be at all times under the control of two or more competent attendants.
