but Lieutenant Ellis, who was separated from the man by four other men in a narrow trench, at once forced his way past them and seized the rifle. Failing to extract the grenade, he dropped the rifle and placed his steel helmet over the grenade, which at once exploded, severely injuring him. There can be no doubt that his prompt and courageous action greatly minimised the force of the explosion and saved several men from death or severe injury.

Mr. Douglas William Wright, formerly Second-Lieutenant, 22nd Battalion, Royal Fusiliers.

In April, 1917, Lieutenant Wright was in charge of a rifle-grenade practice at St. Pol. One of the party accidentally released the safety lever of his grenade before he was ready to fire, and thereupon threw his rifle on the ground, calling to Lieutenant Wright to escape. The officer, however, fearing that the man would be unable to get away in time, rushed past him, seized the rifle, and held it to his body in order to minimise the force of the explosion. He was so severely injured as to necessitate the amputation of both legs and one arm. The man who was firing escaped from the trench by another exit.

Lieutenant Wright undoubtedly risked his life in endeavouring to save the life of another.

And I further direct that Lisbeth Aron, the wife of the said Maximilian Aron, shall cease to be a British subject.
