TRADE BOARDS ACTS, 1909 AND 1918.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, the Trade Board established under that Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Hollow-ware Trade as defined in the Regulations made by the Board of Trade and dated the 6th July, 1914, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to vary the General Minimum Time Rate for female workers other than learners from 18s. per week of 54 hours to 30s. 9d. per week of 47 hours, with corresponding variations in the General Minimum Time Rates fixed for female learners.
