

burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

(c) In the said portions of the Churchyard in any grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

**W**HEREAS the Minister of Health, after giving to the Incumbent and the Churchwardens of the Parish of Monkton Combe, in the County of Somerset, 10 days' previous Notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that, for the protection of the public health, the opening of any new Burial Ground in the Civil Parish of Monkton Combe, in the said County of Somerset, save with the previous approval of the Minister of Health, should be prohibited, and that Burials should be discontinued therein, as follows, viz.:—

**MONKTON COMBE.**—Forthwith and entirely in the Burial Ground attached to the Union Chapel, Combe Down.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation, and to order that the same be taken into consideration by a Committee of the Privy Council on the 10th day of September next.

And His Majesty is further pleased to direct that this Order be forthwith published in the *London Gazette*, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 10th day of September.

STATUTE to alter and amend the Statutes framed by the Commissioners appointed under the Universities of Oxford and Cambridge Act, 1877, 40 & 41 Victoria, cap. 48, and approved by the Queen in Council in the year 1882, in relation to Wadham College, in the University of Oxford, in the matter of the office of the Chaplains, such amending Statute being duly made at a General Meeting of the Governing Body of the said College specially summoned for this purpose, held on the 20th day of June, 1919, and passed by the unanimous votes of those present and voting.

IN Statute VI., Clause 9, before the word "two" insert the words "not more than" and at the end of the Clause add the words "In the event of there being only one Chaplain, he shall receive a yearly stipend of £100."
