Now, therefore, by this Order made in pursuance of the powers conferred upon me by Section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the said certificate and I direct such revocation to have effect from the date hereof and I further order the said certificate to be given up and to be cancelled.

And I further direct that M. Dehe, the wife, and also the minor children of the said August Dehe shall cease to be British subjects.
