Chapelry, Place, or District, Parochial or Extra-Parochial, so as to form a Separate Parish or Benefice, or that any Extra-Parochial Place may with advantage be annexed to any Parish to which it is contiguous, or be constituted a Separate Parish for Ecclesiastical Purposes; and the said Archbishop, or Bishop, shall draw up a Scheme in writing (the Scheme of such Bishop to be transmitted to the said Archbishop for his consideration) describing the mode in which it appears to him that the alteration may best be effected, and how the changes consequent on such alteration in respect to Ecclesiastical Jurisdiction, Glebe Lands, Tithes, Rent Charges, and other Ecclesiastical Dues, Rates and Payments, and in respect to Patronage and Rights to Pews, may be made with justice to all parties interested; and if the Patron or Patrons of the Benefice or Benefices to be affected by such alteration shall consent in writing under his or their hands to such Scheme, or to such modification thereof, as the said Archbishop may approve, and the said Archbishop shall, on full consideration and inquiry, be satisfied with any such Scheme, or modification thereof, and shall certify the same and such Consent as aforesaid, by his Report to His Majesty in Council, it shall be lawful for His Majesty in Council to make an Order for carrying such Scheme, or modification thereof, as the case may be, into effect."

And whereas the Right Reverend Frank Theodore, Lord Bishop of Peterborough, hath made a Representation in writing, dated the 21st day of June, 1919, to the Right Honourable and Most Reverend Randall Thomas, Lord Archbishop of Canterbury, as follows:-

"We, the Right Reverend Frank Theodore, Lord Bishop of Peterborough, in pursuance of the 26th Section of the Pluralities Act, 1838, do hereby represent to your Grace that there is, in the County of Leicester, and my Diocese of Peterborough, Benefice of Loughborough: Peterborough, the Rectory or

"That included in the said Rectory or Benefice is the District known as Knight

"That the Patrons of the said Benefice of Loughborough are the Master, Fellows, and Emmanuel College, in of University of Cambridge, and that the Rector of the said Benefice is the Reverend George Wallace Briggs, Clerk, M.A.:
"That the population of the Parish of

Loughborough, including the said District known as Knight Thorpe, according to the

last census was 9,604:

"That there is a house of residence within the said Rectory or Benefice of Lough-

borough:

"That the population of the said District known as Knight Thorpe is now estimated at

"That the net annual value of the said Rectory or Benefice of Loughborough is

£1,050: "That there is a Church in the said Parish of Loughborough which affords accommodation

for 1,000 persons:
"That it does not appear that any of the Inhabitants or Land owners of Knight Thorpe possess any legal right by Faculty or otherwise to the exclusive use of any pews or sittings in the Church of Loughborough:

"That contiguous to the said Parish of Loughborough is the Parish and Vicarage or Benefice of Thorpe Acre:

"That I, the said Frank Theodore, am, in right of my Bishopric, the Patron of the said Benefice of Thorpe Acre and that the Vicar or Incumbent of the said Vicarage is the Reverend

Robert James Sturdee, Clerk, M.A.:
"That the population of the Parish of Thorpe Acre according to the last census was

"That the net annual value of the said Vicarage or Benefice of Thorpe Acre is £142:

"That there is a Church in the said Parish of Thorpe Acro which affords accommodation

for 150 persons:

"That there is a house of residence within the said Vicarage or Benefice of Thorpe Acre:

'That part of the endowments of the Rectory and Benefice of Loughborough consisting of £1,428 11s. 6d. London County £3 10s. 0d. per cent. Stock at present held by the Ecclesiastical Commissioners, should, as from the date of the alteration of boundaries hereinafter proposed, be transferred from such Rectory and Benefice and should be annexed to and should in future form part of the endowments

of the Vicarage and Benefice of Thorpe Acre:
"That it appears to me that under the provisions of the said Pluralities Act, 1838, the said District known as Knight Thorpe which is coloured pink on the accompanying plan may with advantage to the interests of Religion be separated from the said Rectory or Benefice of Loughborough and be annexed to the said Vicarage or Benefice of Thorpe Acre for all

Ecclesiastical purposes:

'That pursuant to the directions contained in the said Acts of Parliament I, the said Lord Bishop, have drawn up a scheme in writing annexed to this representation describing the mode in which it appears to me that the alteration above proposed may best be effected and how the changes consequent on such alteration in respect to Ecclesiastical Jurisdiction, Glebe Lands, Tithes, Rent Charges, and other Ecclesiastical Dues, Rates, and Payments and in respect to Patronage and Rights to Pews may be made with justice to all parties interested and I do hereby submit the same together with the Consents in writing of the said Patrons and Incumbents of the said Benefices to the intent that if your Grace shall on full consideration and enquiry be satisfied with such Scheme you may certify the same and such Consents as aforesaid to His Majesty in Council."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:--

"SCHEME,

"That the District known as Knight Thorpe coloured pink on the accompanying map or plan and which is included under that name within the boundaries of the Borough of Loughborough as settled by the Local Government Board on March 23rd, 1891, shall be for all Ecclesiastical purposes separated from the Rectory or Benefice of Loughborough and be annexed to the Vicarage or Benefice of Thorpe Acre and the Rector or Incumbent of the said Rectory or Benefice of Loughborough shall be exempt from all cure of Souls within the said District of Knight Thorpe and the Vicar or Incumbent of Thorpe Acre shall have exclusive Cure of Souls within the same:

"That the Inhabitants residing within the said District of Knight Thorpe shall not be
