entitled to any pews or sittings or other accommodation within the Church belonging to the said Parish of Loughborough and shall be exempt from all rates, charges and assess ments to be made for or in respect of the Church or Chancel of Loughborough aforesaid:

"That a sum of £1,428 11s. 6d. London County £3 10s. Od. per cent. Stock forming part of the endowments of the Rectory and Benefice of Loughborough and at present held by the Ecclesiastical Commissioners in favour of that Rectory and Benefice shall henceforth be transferred to and form part of the endowments of the Vicarage and Benefice of Thorpe Acre and shall be held by the Ecclesiastical Commissioners in favour of the said Vicarage and Benefice of Thorpe Acre.

"We, the undersigned, Randall Thomas, 'Archbishop of the Province of Canterbury, do hereby report to your Majesty in Council:

"That the Right Reverend Frank Theodore, Lord Bishop of Peterborough, in pursuance of the 26th Section of the Pluralities Act, 1838, has represented unto Us amongst other things:

"That there is in the County of Leicester and his Diocese of Peterborough the Benefice of Loughborough containing a population of 9,604 according to the last Census:
"That included in the said Benefice is the

District known as Knight Thorpe with an estimated population of 193:

"That there is also in the same County and Diocese and contiguous to the said Benefice of Loughborough the Benefice of Thorpe Acre containing a population according to the last Census of 160:

"That it appears to the said Lord Bishop that under the provisions of the said Act the said District known as Knight Thorpe which is coloured pink on the Plan annexed to the hereinafter mentioned Scheme of the said Lord Bishop may be advantageously separated from the Benefice of Loughborough and annexed to

the Benefice of Thorpe Acre:

'That pursuant to the directions contained in the said Pluralities Act the said Lord Bishop has drawn up a Scheme in writing describing the mode in which it appears to him that the proposed alterations may best be effected and how the changes consequent upon such alterations in respect of Ecclesiastical Jurisdiction, Glebe Lands, Tithe Rent Charges and other Ecclesiastical Dues, Rates and Payments and in respect to Patronage and Rights to Pews may be made with justice to all parties interested, which Scheme, together with the Consents in writing of the Master, Fellows and Scholars of Emmanuel College in the University of Cambridge, the Patrons or persons entitled to present to the Benefice of Loughborough, The Reverend George Wallace Briggs, the Incumbent of the same Benefice, the said Lord Bishop of Peterborough, in right of his Bishopric, the Patron or person entitled to present to the Benefice of Thorpe Acre and The Reverend Robert James Sturdee, the Incumbent of the same Benefice, has been transmitted to Us for our consideration:

"The Representation and Scheme of the said Lord Bishop and the Consents above referred

to are hereunto annexed:
"And We, the said Archbishop, being on full consideration and enquiry satisfied with the said Scheme, do hereby pursuant to the said Pluralities Act, certify the same and such Consents as aforesaid to your Majesty in Council to the intent that your Majesty in Council may, in case your Majesty in Council shall think fit so to do, make and issue an Order for carrying the said Scheme into effect."

Now, therefore, His Majesty in Council, by and with the advice of His said Council, is pleased to order, as it is hereby ordered, that the said Scheme be carried into effect.
