"15 (a) The provisions of Clause 14 shall be subject to the conditions that the appointment to each of the said Professorships shall be vested in an Electoral Board to be constituted by a Statute or Statutes for the University, and that of each Board so constituted two Electors, of whom one at least shall be a member of College and the other a person eminent for learning, shall always be appointed by the President and Fellows of the College, and shall each hold office for five years and be eligible for re-election at the expiration of the period of office for which he was appointed.'

Instead of Clause 20 (d) of the Statutes made for Corpus Christi College, Oxford, by the University of Oxford Commissioners, and approved by Her late Majesty Queen Victoria in Council on the 3rd day of May, 1882, and instead of the alterations made in the same Clause of the Statutes by the College, and approved by Her late Majesty Queen Victoria in Council on June 24th, 1885, the following

Clause shall be substituted:-

Clause 20 (d). The stipend of an Assistant Tutor shall be not less than £100 per annum, nor more than £200 per annum, at the time of his first appointment. stipend may be increased annually by a sum not exceeding £50 per annum, but it shall not during the first ten years of his tenure of office exceed £300 per annum. After an Assistant Tutor has completed 10 years' service of the College the College may, with his assent, increase his income on such conditions and to such extent as it may decide, provided always that the income which he

draws from the College as Assistant Tutor shall never exceed £600 per annum in addition to his emoluments as a Fellow; and provided that, when the stipend of an Assistant Tutor exceeds £500 per annum, the payments made to an Assistant Tutor by way of stipends shall be conditional on his giving his whole time to the educational work of the College, and not accepting or undertaking, without the consent of the College, any office or educational work elsewhere, which is, in their judgment incompatible with the full performance of his work for the College. The stipend of an Assistant Tutor shall for the first ten years of his tenure of office be paid one-half out of the Tuition Fund and one-half out of the revenues of the College. Should the College after that period has expired decide to increase his income, it may, if it so wish, provide for that increase out of the revenues of the College. Nor shall an Assistant Tutor whose stipend has been advanced beyond £500 per annum be eligible for re-appointment after thirty-two years have elapsed from the time of this.

In Clause 20 (b) after the words "an Assistant Tutor may be reappointed by the President for any further period not exceeding seven years, and so from time to time subject as aforesaid to the approval of the College," the following words shall be added "unless the College has in the meantime increased his income after ten years' service in the manner provided by Clause 20 (d), in which case his reappointment shall rest with the College."

In Clause 77 (3) and after the word "payable," the following words shall be added "but not the additional charges created for Assistant Tutors under Clause 20 as approved by His Majesty King George the Fifth in Council on 1919" ["1920."]
