Any objection to the proposed Order must be sent to the Secretary of State at the Home Office, Whitehall, London, S.W. 1, within 21 days after the date of this Notice. The objection must be in writing, and must state:—

(a) the requirements in the draft Order objected to;

(b) the specific grounds of objection; and

(c) the modifications asked for.

Where an objection is made jointly on behalf of a number of occupiers, the names of the occupiers and their addresses must be stated, or, if the objection is made by an association of occupiers on behalf of its members, the number of the members affected by the Order.

#### BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Otto Johann Mathias Ritter Von Pischhof.

Revocation of Certificate of Naturalization.

Whereas I am satisfied as the result of an enquiry conducted by the Certificates of Naturalization (Revocation) Committee that Otto Johann Mathias Ritter Von Pischhof, to whom a certificate of naturalization, numbered 22117, was granted on the 19th June, 1912, has shown himself by act to be disaffected and disloyal to His Majesty.

Now, therefore, by this Order, made in pursuance of the powers conferred upon me by Section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the said certificate, and I direct such revocation to have effect from the date hereof, and I further order the said certificate to be given up and to be cancelled.
