COUNTY OF MIDDLESEX.

(FELTHAM, YIEWSLEY AND UXBRIDGE.)

Notice is hereby given, that the Minister of Health, by an Order dated the 12th day of September, 1919, has made a Regulation under Section 9 of the Motor Car Act, 1903, which will come into operation on the 1st day of October, 1919, limiting to ten miles per hour the speed at which a motor car may be driven within the limits comprising the undermentioned parts of roads :—

In the Urban District of Feltham.

So much of the High Street as extends from a point in the road on the crown of the Railway Bridge to a point in the road opposite the Parish Room;

So much of the road leading from Feltham to Hanworth as extends from its junction with the High Street to a point in the road opposite the Magistrates' Court;

So much of Bedfont Lane as extends from its junction with the High Street to a point distant 100 yards north-west of the Railway (level) Crossing; and

So much of Feltham Road as extends from the junction of the Ashford and Sunbury Roads to a point distant 200 yards north-east of the entrance to Cedar Lodge;

In the Urban District of Yiewsley and the Rural District of Uxbridge.

So much of the road from Uxbridge to Harmondsworth as extends from Philpott's Bridge, Yiewsley, to the junction of the Harmondsworth and Sipson Roads, West Drayton.
