Special Acts (Extension of Time) Act, 1915: Further extending times limited by Section 58 of the Metropolitan Water Board (New Works) Act, 1911, and by Sections 21, 48 and 82 of the Metropolitan Water Board Act, 1913.

METROPOLITAN WATER BOARD.

To the Metropolitan Water Board ;-And to all others whom it may concern

W HEREAS by virtue of Section 58 of the Metropolitan Water Board (New Works) Act, 1911 (hereinafter referred to as "the Act of 1911"), and of Orders dated re-spectively the 22nd day of July, 1916, the 19th day of June, 1917, and the 29th day of August, 1918, issued by the Local Government Board, under Section 1 of the Special Acts (Extension of Time) Act, 1915 (hereinafter referred to as " the Act of 1915 "), the time limited for the exercise by the Metro-politan Water Board (hereinafter referred to as "the Water Board ") of their powers for the compulsory purchase of the lands and easements required for the purposes of the filter beds and other works referred to in Section 51 of the Act of 1911 and for the purposes of the works referred to in that Act as Conduits Nos. 12 to 15 and 23, Reservoirs Nos. 5, 9, and 10, Aqueducts Nos. 1 to 13, and Roads Nos. 5 and 6, expired on the 18th day of August, 1919;

And whereas by virtue of Section 21 of the Metropolitan Water Board Act, 1913 (herein-after referred to as "the Act of 1913"), as applied by Section 75 of that Act, and of Orders dated respectively the 30th day of November, 1917, and the 29th day of August, 1918, issued by the Local Government Board, under Section 1 of the Act of 1915, the time limited for the exercise of the powers granted to the Water Board by the Act of 1913 for the construction of the works referred to in the said Section 75 expired on the 15th day of August, 1919 ;

And whereas by virtue of Section 48 of the Act of 1913, and of the said Order dated the 29th day of August, 1918, the powers of the Water Board for the compulsory purchase or taking of lands or easements under the Act of 1913 for the purposes of the construction of the works referred to in that Act as Conduit No. 1 and Aqueduct No. 1 ceased on the 15th day of August, 1919;

And whereas in pursuance of Section 1 of the Act of 1915 the Water Board applied before the expiration of the various times limited as aforesaid for an Order extending those times

And whereas by Section 82 of the Act of 1913 provision is made for enabling the Water Board to borrow money by way of temporary loan or overdraft for the purpose of providing temporarily during any financial year for their current expenses, and by virtue of sub-section (2) of that Section and of the said Order dated the 29th day of August, 1918, the provisions of the Section will, unless continued as mentioned in the Section, cease to be in force on

the 31st day of March, 1920: Now therefore, the Minister of Health, in pursuance of the powers given to him in that behalf, hereby extends-

(a) until the 18th day of August, 1920, the time limited as aforesaid for the exer-

cise of the powers of the Water Board for the compulsory purchase of the lands and easements required for the purposes of the filter beds and other works referred to in Section 51 of the Act of 1911, and for the purposes of the works referred to in that Act as Conduits Nos. 12 to 15 and 23, Reservoirs Nos. 5, 9, and 10, Aqueducts Nos. 1 to 13, and Roads Nos. 5 and 6; and

(b) until the 15th day of August, 1920, the time limited for the exercise by the Water Board of the powers granted them by the Act of 1913 for the construction of the works referred to in Section 75 of that Act; and

(c) until the 15th day of August, 1920, the time limited as aforesaid for the compulsory purchase or taking of lands or easements under the Act of 1913 for the purposes of the construction of the Works referred to in that Act as Conduit No. 1 and Aqueduct No. 1; and

(d) until the 31st day of March, 1921, the time limited as aforesaid for the continuance in force of the provisions of Section 82 of the Act of 1913.

Special Acts (Extension of Time) Act, 1915: Further extension of time limited by Section 13 of the Southport Corporation Act, 1913.

BOROUGH OF SOUTHPORT.

To the Mayor, Aldermen, and Burgesses of the Borough of Southport :-

And to all others whom it may concern.

WHEREAS by virtue of Section 13 of the Southport Corporation Act, 1913 (hereinafter referred to as "the Act of 1913 ''), and of an Order dated the 14th day of August, 1918, issued by the Local Government Board under Section 1 of the Special Acts (Extension of Time) Act, 1915 (hereinafter referred to as "the Act of 1915") the time limited for the exercise by the Mayor, Alder-men and Burgesses of the Borough of Southport (hereinafter referred to as "the Corporation ") of their powers for the compulsory purchase of lands under the Act of 1913, expired on the 15th day of August, 1919;

And whereas in pursuance of Section 1 of the Act of 1915 the Corporation applied before the expiration of the time limited as aforesaid for

an Order extending that time: Now therefore, the Minister of Health, in pursuance of the powers given to him in that behalf, hereby extends until the 15th day of August, 1920, the time limited as aforesaid for the exercise of the powers of the Corporation for the compulsory purchase of the lands aforesaid.
