**WARRINGTON.**

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Warrington (hereinafter called the Corporation), being the Urban Sanitary Authority, for the said Borough, have made application to the Ministry of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter, or amend the Warrington Corporation Gas Act, 1877, and the Acts of Parliament and Orders confirmed by Parliament amending and extending the same so as—

(1) To empower the Corporation to borrow such sums, not exceeding in the whole the sum of £250,000, as may from time to time be necessary for the purposes of their gas undertaking and as may be sanctioned by the Ministry of Health;

(2) To extend the period fixed by the Warrington Order, 1896, for the repayment of money borrowed by virtue of that Order for the purposes of the said gas undertaking; and

(3) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes

to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable;

Notice is hereby given that it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is also given that the Ministry of Health will consider any objections which may be made to them in writing before the 3rd day of November, 1919, by any persons affected by the proposed Provisional Order.

**RHYMNEY VALLEY SEWERAGE BOARD.**

Whereas the Rhymney Valley Sewerage Board (hereinafter called "the Board") have made application to the Ministry of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter or amend the Rhymney Valley Sewerage Board Act, 1912, so as:—

(1) To substitute four years from the commencement of the Provisional Order for seven years from the passing of the Act as the period limited by Section 43 of the said Local Act for the completion of the works authorised by the Act;

(2) To provide that Section 88 (1) (A) of the Local Act shall be read and have effect as though the sum of five hundred and sixty thousand pounds had been therein substituted for the sum of two hundred and twenty-two thousand pounds authorised to be borrowed by the Board under that provision;

(3) To amend the provisions of the Local Act with regard to the rate of accumulation of sinking funds for the repayment of moneys borrowed under the Act; and

(4) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the district of the Sewerage Board as may be necessary or desirable;

And whereas it appears to the said Ministry that the completion of the works authorised by the said Act of 1912, has been delayed and the expenditure in relation thereto increased, by circumstances arising out of the present war.

Notice is hereby given, that it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is also given, that the Ministry of Health will consider any objections which may be made to them in writing before the 3rd day of November, 1919, by any persons affected by the proposed Provisional Order.
