

Board of Trade.—Session 1920.

Huddersfield Electric Lighting (Extension to Kirkheaton, Kirkburton, Lepton and Meltham).

(Provisional Orders.)

(The Supply of Electricity by the Corporation of Huddersfield in the Urban Districts of Kirkheaton, Kirkburton, Lepton and Meltham; Extension of the Areas of Supply defined by the Existing Orders of the Corporation.)

NOTICE is hereby given, that the Mayor, Aldermen and Burgesses of the county borough of Huddersfield (hereinafter called "the Corporation"), whose address is the Town Hall, Huddersfield, intend to apply to the Board of Trade on or before the 20th day of December next for a Provisional Order or Orders (hereinafter called "the Order or Orders") under the Electric Lighting Acts, 1882 to 1909, for all or some of the following amongst other purposes (that is to say):—

1. To extend the areas of supply under the Huddersfield Electric Lighting Order, 1896, the Huddersfield (Extension to Linthwaite) Electric Lighting Order, 1903, the Huddersfield (Extension to Golear) Electric Lighting Order, 1904, and the Huddersfield (Extension to South Crosland) Electric Lighting Order, 1910 (hereinafter referred to as "the Orders of 1896, 1903, 1904 and 1910"), as extended by the Huddersfield Corporation Act, 1913, by adding thereto the urban districts of Kirkheaton, Kirkburton, Lepton and Meltham in the West Riding of the county of York (hereinafter referred to as the "added areas").

2. To authorize the Corporation to generate, supply, distribute and sell electrical energy for all public and private purposes as defined by the Electric Lighting Acts, 1882 to 1909, within the added areas.

3. To extend and make applicable to the added areas all or some of the powers and provisions contained in the Huddersfield Electric Lighting Order, 1890, and the Orders of 1896, 1903, 1904 and 1910, and in the local Acts of the Corporation relating to their electricity undertaking, and to apply such provisions to the undertaking or undertakings to be authorized by the Order or Orders subject to such variations and exceptions as may be contained therein.

4. To incorporate in the Order or Orders such of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act, 1899, as are applicable, and to apply such provisions to the undertaking or undertakings to be authorized by the Order or Orders, subject to such variations and exceptions as may be contained therein.

5. To alter, extend and amend the provisions of the Huddersfield Electric Lighting Order, 1890, and the Orders of 1896, 1903, 1904 and 1910.

6. The names of the streets in the added areas in which it is proposed that electric lines shall be laid down within a period to be specified by the Order or Orders are as follows:—

In Kirkheaton:

Hillside-lane, from Council boundary to

St. Mary's-lane; St. Mary's-lane, from Hillside-lane to Shop-lane; Shop-lane, from St. Mary's-lane to town.

In Kirkburton:

Dogley-lane, from Council's boundary to Dogley-bar; Far-dean, from Dogley-lane to Slant-gate; Slant-gate, from Far-dean to North-road; North-road, from Slant-gate to Shelley-lane.

In Lepton:

Wakefield-road, from Borough boundary to Cowms; Lascelles Hall-lane, from Cowms to Lascelles Hall; Highgate-lane, from Cowms to Wakefield-road; Wakefield-road, from Highgate-lane to Pinfold-lane; Station-road, from Highgate-lane to Dogley-lane; Dogley-lane, from Station-road to Council's boundary.

In Meltham:

Meltham-road, from Bent Ley-bridge to Town-gate; Town-gate, from Meltham-road to Market-place.

On or before the 29th day of November instant a copy of this notice, as published in the London Gazette, and maps showing the added areas and the streets in which it is proposed that electric lines shall be laid down within a specified time will be deposited for public inspection with the Clerk of the Peace for the West Riding of the County of York at his office at Wakefield, with the Clerk of the Urban District Council of Kirkheaton at his office at Hillside, Kirkheaton, with the Clerk of the Urban District Council of Kirkburton at the Council Offices, Kirkburton, with the Clerk of the Urban District Council of Lepton at his office at the dwelling-house of Frank Hardy, Haigh's-buildings, Lepton, and with the Clerk of the Urban District Council of Meltham at his office at the Town Hall, Meltham, and also at the offices of the Board of Trade, Whitehall, London.

Printed copies of the draft Provisional Order or Orders will be deposited at the said offices of the Board of Trade on or before the 20th day of December next, and printed copies of the draft Order or Orders when deposited and of the Order or Orders when made may be obtained at the offices of the undersigned, and at the aforesaid office of the Clerk to each of the said urban district councils on payment of one shilling for each copy.

Every local or other public authority, company or person desirous of bringing before the Board of Trade any objection respecting the application must do so by letter addressed to the Board of Trade marked on the outside of the cover enclosing it "Electric Lighting Acts," on or before the 15th day of January next, and a copy of such objection must also be forwarded to the offices of either of the undersigned.
