(LIQUOR CONTROL).

ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE BRISTOL AND BATH AREA.

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

The Order of the Board made on the fifth day of February, 1918 (prohibiting the sale and supply of spirits for consumption on the premises in licensed premises and clubs in the Petty Sessional Division of Frome, in the County of Somerset, except between the hours of 12 noon and 2.30 p.m. on week-days, and between the hours of 12.30 p.m. and 2.30 p.m. on Sundays) is hereby revoked and shall cease to have effect.

DEFENCE OF THE REALM
(LIQUOR CONTROL).

ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE SOUTHERN MILITARY AND TRANSPORT AREA.

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

The Orders of the Board made respectively on the third day of July, 1917, the twentieth day of December, 1917, and the fifth day of February, 1918 (prohibiting the sale and supply of spirits in licensed premises and clubs for consumption on the premises in certain parts of the area, except between the hours of 12 noon and 2.30 p.m. on week-days, and between the hours of 12.30 p.m. and 2.30 p.m. on Sundays), are hereby revoked and shall cease to have effect.
