TRADE BOARDS ACTS, 1909 AND 1918.

CORSET TRADE BOARD

PROPOSAL TO VARY CERTAIN GENERAL MINIMUM TIME-RATES, PIECE-WORK BASIS TIME-RATES AND OVERTIME RATES FOR MALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, the Trade Board established under the Trade Boards Act, 1918, for the Corset Trade as specified in the Trade Boards (Corset) Order, 1919, hereby give notice, as required by Section 3 (5) of the

Section I.—Cutters; Markers-out (other than Process Workers); Hand Pressers; Matchers-up and Shaders; who have had not less than three years' experience after the age of nineteen years in one or more of the occupations specified in this Section. Provided that for the purpose of reckoning previous experience a worker shall be entitled to count not more than twelve months' experience after the age of nineteen years in any of the occupations specified in Section II. of this Notice.

Section II.—Folders; Hand-Fitters; Parters, Separaters and Makers-up; who have had not less than three years' experience after the age of nineteen years in one or more of the occupations specified in this Section.

Section III.—Overtime Rates calculated on the minimum rates set out above, in the manner set out in the Schedule of the above-mentioned Notice issued by the Trade Board and dated the 26th November, 1919, shall apply in substitution for the above minimum rates, in respect of all hours worked in excess of the number of hours declared by the Trade Board, in the Schedule above referred to, to be the normal number of hours of work in the trade.

Section IV.—No variation is proposed in the minimum rates for Male Workers set out in the above-mentioned Notice, in respect of any class of Male Workers other than those specified above.

Section V.—The above proposed minimum rates are without prejudice to workers who are earning higher rates of wages.

The Trade Board will consider any objections to the above Proposal to Vary which may be lodged with them within two months from 9th December, 1919. Such objections should be in writing, and signed by the person making the same (adding his or her full name and address), and should be sent to the Secre-

Trade Boards Act, 1918 (the Minister of Labour having given his consent to such Notice being given), that they propose to vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates for Male Workers, at present fixed and set out in the Schedule to their Notice dated the 26th November, 1919, and effective under the Order of the Minister of Labour dated the 25th November, 1919, in respect of certain classes of Male Workers, so that in lieu of such minimum rates the General Minimum Time-Rates, Piece-Work Basis Time-Rates and Overtime Rates for the following classes of Male Workers shall be as follows, that is to say:
