**BRIGHTON.**

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Brighton (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Ministry of Health for the issue of a Provisional Order under sections 297 and 303 of the Public Health Act, 1875, to partially repeal, alter, or amend:—

1. The Brighton Corporation Act, 1901, as amended by the Brighton Order, 1911, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 2) Act, 1911, so as:—

(a) To extend the powers, rights and privileges which may be exercised by the Corporation on or in connection with the Aquarium Estate, and in particular to authorise them to carry on sea water, fresh water, swimming, medicated, hydropathic, Spa, Turkish and other baths, and bathing, medical, and other establishments and institutions for or in connection with medical treatment or any healthful or recreative purpose; and for the purpose of providing sea water or fresh water to any such baths; establishments or institutions, or any buildings which the Corporation now or hereafter may be authorised to erect on the Aquarium Estate, to lay down, provide and maintain intakes, pipes, culverts and other works incidental to or necessary for such purposes;

(b) To empower the Corporation to grant leases of the Aquarium Estate for any term not exceeding 60 years as they may think fit, and for such purposes or uses (in addition to those mentioned in section 17 of the said Act of 1901 or to be authorised by the proposed Order) as shall be deemed by the Corporation to be in the best interests of the inhabitants of the Borough;

(c) To extend for a further period of ten years from the 9th August, 1921, the period limited for the completion of the works of widening the Marine Parade and narrowing the Madeira Road which were authorised by section 28 of the said Act of 1901;

(2) The Brighton Corporation Act, 1912, as amended by the Brighton Order, 1917, which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 1) Act, 1917, and the Brighton Corporation Act, 1913, so as:—

(a) To extend the powers of the Corporation of leasing the right of user and of running motor omnibuses so that those powers may also be exercised in respect of any omnibuses provided by the Corporation under the said Act of 1913, or any subsequent Act or Order having the force of an Act.
