A copy of the Order and of the map referred to therein will be deposited for public inspection on Fridays, March 5th, 12th, 19th and 26th, between the hours of 10 a.m. and 3 p.m., at the Town Hall, Leominster, and on other days until March 29th at the office of the Hereford Agricultural Executive Committee, at 1, St. John Street, Hereford.

Since the previous deposit of the Draft Order the provisions with regard to the rates to be levied in the district have been amended in

order to meet certain objections made against the Draft Order by persons interested.

WELSH CHURCH ACT, 1914, AND WELSH CHURCH (TEMPORALITIES) ACT, 1919.

Whereas it is provided by Section 9 (1) of the Welsh Church Act, 1914, that: "The Welsh Commissioners shall, as soon as may be after the passing of this Act, with respect to any ecclesiastical parish part only whereof is situate in Wales or Monmouthshire, by order determine, with reference to the general wishes of the parishioners, whether the parish is to be treated as being wholly within or wholly without Wales or Monmouthshire."

And whereas it is further provided by Section 8 of the Welsh Church (Temporalities) Act, 1919, that: "Where an ecclesiastical parish which before the year eighteen hundred and fifty was situate partly in Wales or Monmouthshire and partly in England has since that year. been divided into two ecclesiastical parishes, one of which is situate wholly in Wales or Monmouthshire and one wholly in England, and both those parishes are situated in an English . diocese, then sub-sections (1) and (3) of section nine of the Welsh Church Act, 1914 (which relates to border parishes), shall apply to the ecclesiastical parish so situate wholly in Wales or Monmouthshire in like manner as if part thereof were situate in England,"

And whereas the Commissioners have held that the said Section 8 of the Welsh Church (Temporalities) Act, 1919, applies to the parish of Whitewell, in the county of Flint and in the diocese of Chester, and to the parish of Trelystan, All Saints, in the county of Montgomery and the diocese of Hereford, and have been satisfied that in both of these ecclesiastical parishes the general wishes of the parishioners are that the parish to which they belong should be treated as being wholly without Wales or Monmouthshire,

The Commissioners do therefore by this Order determine that the ecclesiastical parishes of Whitewell and Trelystan, All Saints, respectively shall, for the purposes of the Welsh Church Act, 1914, and the Welsh Church (Temporalities) Act, 1919, be treated as being wholly without Wales and Monmouthshire.
