OTICE is hereby given, that by an Order dated the 29th day of January, 1920, the Minister of Health has confirmed an Order made on the 17th day of December, 1919, by the Urban District Council of Cleethorpes in pursuance of Section 112 of the Public Health Act, 1875, as amended by Section 51 of the Public Health Acts Amendment Act, 1907, declaring each of the trades, businesses, or manufactures of blood-drier, bone-grinder, tanner, leather-dresser, fat-melter or fatextractor, glue-maker, rabbit-skin drier, sizemaker, gut-scraper, offal and chitterling boiler, rag and bone dealer, fish-frier and manufacturer of manure from fish, fish offal, blood or other putrescible animal matter, within the Urban District of Cleethorpes, to be an offensive trade.

(1) Caution with regard to Navigation.

1. Caution.—Mariners are warned that, owing to the existence of obstructions, certain areas, as defined below, in the western part of Scapa Flow are dangerous for navigation.

(a) In the vicinity of Cava:

Lat. 58° 51′ 50″ N., long. 3° 10′ 28″ W. Description. A red conical light-buoy exhibiting a flashing white light every six seconds.
