(SWINE-FEVER INFECTED AREA.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested. in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power

enabling him in this behalf, hereby orders as follows:

Extension of Limits of Swine-Fever Infected Area.

1. The limits of the Swine-Fever Infected Area declared by Order of the Minister, dated the twenty-fifth day of January, nineteen hundred and twenty, are hereby extended so as to comprise the Area described in the Schedule to this Order, and the Area so described is hereby declared to be a Swine-Fever Infected Area for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908.
