In pursuance of the powers conferred on him by the Trade Boards Acts, 1909 and 1918, the Minister of Labour is pleased, under and by virtue of the Trade Boards (Women's Clothing) Order, 1919, to establish a Trade Board for Dressmaking and the making of Women's

Trade that are engaged in the making of Non-Tailored Garments, namely, the making from textile or knitted fabrics of (a) non-tailored wearing apparel (other than handkerchiefs) worn by women or girls, or by children without distinction of sex, or (b) boys' ready-made washing suits or sailor suits, where carried out in association with or in conjunction with the making of garments to be worn by women or girls, or by children without distinction of sex;

#### including-

1. All operations and processes of cutting, making or finishing by hand or machine of dresses, non-tailored skirts, wraps, blouses, blouse-robes, jumpers, sports-coats, neckwear, tea-gowns, dressing-gowns, dressingjackets, pyjamas, underclothing, under skirts, aprons, overalls, nurses' and ser-vants' caps, juvenile clothing, baby-linen or similar non-tailored articles;
