and having regard to the provisions of the revised Berne Copyright Convention of 1908, was pleased to make an Order in Council, dated the 24th day of June, 1912, Statutory Rules and Orders, 1912, No. 913 (hereinafter called the Principal Order), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention:

And whereas Poland has acceded to the said Convention:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue of the authority conferred upon Him by the Copyright Act, 1911, is pleased to order, and it is hereby ordered, as follows:—

The Principal Order shall extend to Poland as if that country were amongst the Foreign Countries of the Copyright Union therein named, subject to the following modifica-

- (a) The provisions of Article 2, proviso (iii) (a) shall apply as if Poland were included amongst the Foreign Countries named in those provisions.
- (b) In the application of the provisions of Article 3 of the Principal Order to works of which the country of origin is Poland the date of this Order shall be substituted for the Commencement of the Act and for the Commencement of the Principal Order.
- (c) In the application to such works of Sections 1 (2) (d) and 19 of the Copyright Act, 1911, the date of this Order shall be substituted for the Commencement of the Act in Section 19 (7) and 19 (8) wherever that expression occurs, and the 28th January, 1920, for the passing of the Act.
- (d) In the application to such works of the provisions of Section 24 of the Copyright Act, 1911, the date of this Order shall be substituted for the Commencement of the Act wherever that expression occurs in Subsection 1 (a) and for the 26th July, 1910, in Sub-section 1 (b).

And the Lords Commissioners of the Treasury are to give the necessary orders accordingly.

pleased to order that the Defence of the Realm Consolidation Act. 1914, and the Defence of the Realm Consolidation Regulations, 1914, should extend to the Isle of Man, subject to the adaptations therein contained:

And whereas the said Act and Regulations have been amended by certain other Acts and Regulations, which said Acts and Regulations have been extended to the Isle of Man by various subsequent Orders in Council, subject to the adaptations therein contained:

And whereas the said Regulations have been further amended by Order in Council of the

9th February, 1920: And whereas it is expedient to extend portions of the said Order in Council of the 9th

February, 1920, to the Isle of Man:
Now, therefore, His Majesty is pleased, by
and with the advice of His Privy Council, to
order, and it is hereby ordered, that the Regulations (except paragraphs 1 and 2 thereof)
contained in the Order in Council of the 9th
February, 1920, shall extend to the Isle of
Man.

HEREAS by Section 30 of the Municipal Corporations Act, amended by Section 2 of the Municipal Corporations Act, 1893, it is (amongst other things) provided that, if a majority of the whole Council of a Borough agree to petition, and the Council thereupon petition, the King for the alteration of the number and boundaries of the Wards of the Borough, it shall be lawful for His Majesty, from time to time, by Order in Council, to fix the number of Wards into which the Borough shall be divided, and that the Borough shall be divided into that number of Wards, and that where an Order in Council has been so made the Secretary of State shall appoint a Commissioner to prepare a Scheme for determining the boundaries of the Wards and apportioning the Councillors among them:

And whereas a majority of the whole Council of the Borough of Chatham did, on the 30th day of July, 1919, agree to petition, and the Council of the said Borough thereupon petitioned, His Majesty for the alteration of the number and boundaries of the Wards of the said Borough:

And whereas His Majesty was pleased, by His Order in Council of the 9th day of October, 1919, to fix the number of Wards into which the Borough of Chatham should be henceforth divided, and to order and direct that the number of the said Wards should be six:

And whereas on the 24th day of October, 1919, the Right Honourable Edward Shortt, one of His Majesty's Principal Secretaries of State, did appoint Stephen Philpot Low, Esquire, Barrister-at-Law, a Commissioner to prepare a Scheme for determining the boundaries of such Wards, and for apportioning the Councillors of the said Borough among such Wards:

And whereas by Section 30 (5) of the Municipal Corporations Act, 1882, it is provided that, in case of alteration of Wards, the Com-
