**BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.**

In the Matter of Ludwig Hollerbusch.

Revocation of Certificate of Naturalization.

Whereas I am satisfied as the result of an enquiry conducted by the Certificates of Naturalization (Revocation) Committee that Ludwig Hollerbusch, to whom a certificate of naturalization, numbered 17,813, was granted on the 14th January, 1909, has during the late war unlawfully traded and communicated with subjects of enemy states, and has been associated with business which was to his knowledge carried on in such manner as to assist the enemy in such war, and that the continuance of his certificate is not conducive to the public good.

Now, therefore, by this Order, made in pursuance of the powers conferred upon me by section 7 of the British Nationality and Status of Aliens Act, 1914, I revoke the said certificate, and I direct such revocation to have effect from the date hereof, and I further order the said certificate to be given up and to be cancelled.

**COAL MINES ACT, 1911.**

The Secretary of State for the Home Department gives notice that, on the 3rd June, 1920, in pursuance of Section 86 of the Coal Mines Act, 1911, he made General Regulations (in substitution for the General Regulations made under the Act on the 9th September, 1913) to apply to all mines under the Act in which ganister or other stone containing not less than 80 per cent. of silica ( $\text{SiO}_2$ ) is worked with a view to sale or manufacture. The Regulations will come into force on the 1st July, 1920.

**NOTICE TO COMPANIES, MUNICIPAL AUTHORITIES AND BANKERS AS TO TRANSFER OF STOCKS, ETC.**

With reference to the Notice in the London Gazette of June 23rd, 1916, as to the provisions of the Trading with the Enemy Acts and Proclamations in connection with the transfer of securities, the attention of all Companies, Municipal Authorities and Bankers who keep registers or branch or local registers of any annuities, Debenture stocks, Debentures, stocks, shares or securities is called to the fact that as from the coming into force of the Treaty of Peace with Germany on the 10th January, 1920, the provisions of the Treaty of Peace Order, 1919, made in pursuance thereof, now apply to the property, rights and interests of German nationals, wherever resident.

Therefore, while the position as regards persons or body of persons resident or carrying on business in Austria, Bulgaria, Hungary and Turkey has not at present altered and they remain "enemies" subject to the Trading with the Enemy legislation until a Treaty of
