And whereas the said Scheme drawn up by the said Archbishop and the Consents of the Patrons and Incumbents of the said Benefices respectively are as follows:-

"SCHEME.

"1. The separation of those parts of the respective Parishes of St. John Newland, St. Matthew, St. Mary Lowgate, Holy Trinity, St. Paul, St. Barnabas, St. Mary Sculcoates from those Parishes as described in the Representation hereunto annexed and the annexation of the same to the several Parishes specified in the said Representation respectively. "2. The Incumbents of the various Parishes

from which the said parts are so separated as aforesaid shall cease to have Cure of Souls within such parts proposed to be transferred and the Incumbents of the various Parishes to which they are prepared to be so transferred shall have sole and exclusive Cure of Souls within the same respectively. "3. The Inhabitants of the said portions of

the various Parishes proposed to be so trans-ferred respectively shall be exonerated from all liability to repair the Parish Churches to which they now belong but shall be liable with the other Inhabitants subject to the provisions of 'The Compulsory Church Rate Abolition Act 1868' to the repair of the Parish Churches to which they are proposed to be transferred respectively and they shall have the same rights as to Pews and the performance of all Offices and Services of the Church at the Parish Churches to which the said parts are so proposed to be transferred and the Parishes belonging thereto as the other Inhabitants

thereof respectively. "4. The fees for such Offices and Services performed for the Inhabitants of the said portions of the various Parishes proposed to be transferred as aforesaid or arising within the limit of the same and usually payable to the Incumbent of a Benefice shall belong to the Incumbents of the various Parishes and Benefices to which they are proposed to be trans-ferred as aforesaid respectively.

"5. No alteration shall be made in respect of the Patronage or any Glebe Land, Tithe, Tithe Rentcharge or other Endowment of any of the said Benefices or Parishes proposed to be affected by this Scheme.
