INCREASE OF RATING AND BORROWING POWERS.

EAST SUSSEX AND KENT (FOOT-AND-
MOUTH DISEASE) ORDER OF 1920
(No. 6).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of Scheduled District.

1. The East Sussex and Kent (Foot-and-Mouth Disease) Order of 1920, and the East Sussex and Kent (Foot-and-Mouth Disease) Order of 1920 (No. 3), shall apply only to the area described in the Schedule to this Order, which shall be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920.

Commencement.

2. This Order shall come into operation on the sixth day of July, nineteen hundred and twenty.

Short Title.

3. This Order may be cited as the EAST SUSSEX AND KENT (FOOT-AND-MOUTH DISEASE) ORDER OF 1920 (No. 6), and shall be read with the Orders referred to in Article 1.

SCHEDULE.

Contracted Prohibited Area.

An Area comprising the fields known as Sheep House, Oakhill, Pigs Creet, House Land (including house, premises and paddock), Smith Land, and Kennell Land, in the occupation of Walter Finn Kelcey; the field known as Lower Widney, in the occupation of Harold Finn; the field known as Eleven Acres, in the occupation of Albert Finn Kelcey; the fields known as The Threads (consisting of ten acres and sixty-five acres), in the occupation of Herbert J. Blacklocks; the field known as the Thunder Pits, in the occupation of William Blacklocks; the fields known as Big and Little Charity, in the occupation of George Braun; the field known as Washpits, in the occupation of A. Morfe; and the fields known as Fifteen Acres, and Big and Little Sandyland, in the occupation of Arthur Finn and Rickards, all situated at Scotney, in the parish of Broomhill, in the administrative county of East Sussex.

ORDER OF THE MINISTER OF

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

*Application of Sheep (Double Dipping)
Order of 1920.*

1.—(1) Part I. (*Restriction on Movement of Sheep out of a Movement Area*) and Part II. (*Double Dipping of Sheep in a Double Dipping Area*) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the Principal Order," are hereby applied, subject to the modifications hereinafter contained, to the Area described in the Schedule hereto, which shall be a Movement Area and a Double Dipping Area for the purposes of that Order.

(2) The Sheep Dipping (England and South Wales) Order of 1915 shall not apply to the Area described in the Schedule hereto, or to sheep therein.

*Provision for Movement of Sheep out of Area
for Dipping.*

2. The double dipping of sheep in accordance with Part II. of the principal Order shall, where practicable, take place within the Area, but an Inspector of the Local Authority may, if satisfied that dipping within the Area in any particular case is impracticable, grant a licence for the movement of any sheep to specified premises outside the Area for the purpose of being dipped, and any licence so granted may impose such conditions as to the movement, detention, isolation and dipping of the sheep as the Inspector may consider desirable.

Period Prescribed as Double Dipping Period.

3. The dates between which all sheep in the Area described in the Schedule hereto are to
