Article 8 of the Sheep (Double Dipping) Order of 1920, shall, in its application to the Double Dipping Area, described in the Schedule hereto, be read and have effect as if, for the words "within twenty-eight days before the date of entry or exposure been dipped twice therein," the words "within the prescribed double dipping period been dipped twice," were substituted.

2. This Order shall come into force on the first day of August, nineteen hundred and twenty.
