We the Master and Fellows of Corpus Christi College in the University of Cambridge in exercise of the powers given to us by the 54th section of the Universities of Oxford and Cambridge Act 1877 (40 and 41 Victoria Chapter 48) did at a General Meeting of the Governing Body of the said College specially summoned for this purpose held on the 3rd day of August 1920 by the votes of not less than two-thirds of the persons present and voting make the Statutes hereunto annexed for the. said College such Statutes to be in substitution for the existing Statutes of the said College; and we do on the date hereunder mentioned seal the Statutes hereunto annexed for Corpus Christi College in the University of Cambridge and do hereby declare them to be Statutes wholly for the said College within the meaning of Section 30 of the said Act.

Ad perpetuam rei memoriam.
