the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Elworthy, in the County of Somerset and in the Diocese of Bath and Wells:

"Whereas by virtue of an Indenture dated the 29th day of April, 1919, and made between Isabel Florence Gardner McTaggart, of Monksilver Rectory, Williton, Widow of the late Reverend George Henry Somerset Gardner McTaggart, Clerk in Holy Orders, of the one part, and the Dean and Canons of Your Majesty's Free Chapel of Saint George within Your Castle of Windsor (hereinafter called 'the said Dean and Canons of Windsor') of the other part, it was witnessed that the Advowson or right of Patronage of and presentation to the said Benefice of Elworthy was conveyed unto and to the use of the said Dean and Canons of Windsor and their successors, in fee simple:

"And whereas the said Conveyance was made with the intention of vesting the said Advowson or perpetual right of Patronage or presentation in the said Dean and Canons of Windsor and the parties thereto are desirous that anything which by way of further assurance or otherwise may be required effectually to carry out that intention may be done and have applied to us, the said Ecclesiastical Commissioners, that a Scheme under the Acts hereinbefore mentioned may be prepared for the said purpose and sub-

mitted to Your Majesty in Council:

"And whereas the said Isabel Florence Gardner McTaggart and the said Dean and Canons of Windsor are consenting to this Scheme, and in token of such consents have executed the Scheme as hereinafter mentioned:

"And whereas the Right Reverend George Wyndham, now Bishop of Bath and Wells, is consenting to the transfer of Patronage which is hereinbefore mentioned and which is hereinafter recommended and proposed and in token of such his consent which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said George Wyndham, Bishop of Bath and Wells, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Elworthy which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as afore-said arises or exists, that is to say in the Parish of Elworthy:

"Now, therefore, with the consent of the said Isabel Florence Gardner McTaggart (in testimony whereof she has signed and sealed this Scheme), with the consent of the said Dean and Canons of Windsor (in testimoney whereof they have caused their common or capitular Seal to be affixed to this Scheme), and with the consent of the said George Wyndham, Bishop of Bath and Wells (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), We, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day

of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme, and without any conveyance or assurance in the law other than such duly gazetted Order, the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Elworthy shall be transferred to the said Dean and Canons of Windsor and their successors, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Dean and Canons of Windsor and their successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Bath and Wells.
