WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Saint Mary Stockport Rectory Act, 1910 do hereby subject as hereinafter mentioned grant to the Incumbent of each of the Benefices (all in the County of Chester and in the Diocese of Chester) whereof the names are stated in the first column of the Schedule hereto and to his successors Incumbents of the same Benefice one yearly sum or stipend of the amount stated in the second column of the said Schedule opposite to the name of the Benefice such yearly sum or stipend to be payable out of the Saint Mary Stockport Rectory (Income) Account in accordance with the provisions of the said Act and to be calculated as from the twenty-fifth day of December in the year One thousand nine hundred and nineteen and to be receivable in equal quarterly portions on the twenty-fifth day of March, the twenty-fourth day of June, the twenty-ninth day of September and the twentyfifth day of December in each and every year: Provided that the yearly sums hereby granted are, in case of deficiency of income of the said Saint Mary Stockport Rectory (Income) Account subject to abatement in accordance with the provisions of the said Act.
