## ABERCARN URBAN DISTRICT.

To the Urban District Council of Abercarn,—

And to all others whom it may concern.

WHEREAS by the Abercarn Order, 1914 (hereinafter referred to as "the Order"), which was confirmed by the Local Government Board's Provisional Orders Confirmation (No. 12) Act, 1914, the Urban District Council of Abercarn (hereinafter referred to as "the Council") were empowered, for the purpose of widening, opening, enlarging, or otherwise improving the street known as Kendon Road, to put in force, with reference to the lands described in the Schedule to the Order, the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement;
