#### MOTOR CAR ACT, 1903.

##### COUNTY OF HUNTINGDON.

Whereas by sub-section 1 of Section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public on the application of the Local Authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the power to make such regulations has been transferred to the Minister of Transport:

Notice is hereby given, that the County Council of Huntingdon have made application for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following roads or parts of roads in the Urban District of Ramsey, that is to say:—

So much of High Street as extends from the Great Eastern Railway Gates to Ramsey Church; and

So much of Great Whyte Street as extends from the Gas Works to High Street.

Notice is hereby further given, that objections to the making of any such regulation may be sent in writing to the Assistant Secretary, Roads Department, Ministry of Transport, 7, Whitehall Gardens, London, S.W. 1, on or before the twenty-fourth day of November, 1920.

A copy of any such objection should be sent at the same time by the objector to the Clerk to the County Council of Huntingdon, County Council Office, Huntingdon.
