LAND DRAINAGE ACTS, 1861 AND 1918.

CHELMER AND BLACKWATER DRAINAGE DISTRICT.

Notice is hereby given, that the Minister of Agriculture and Fisheries has settled and made an Order under the Land Drainage Act, 1918, constituting a drainage district for certain lands drained by the Chelmer and Blackwater, and that the Order will become final and have effect as an Act of Parliament unless within thirty days from the date of this notice a memorial that the Order shall not become law without confirmation by Parliament is presented to the Ministry by some person or body affected by the Order, and having such interest as is prescribed by Article 4 of the Land Drainage Regulations, 1918 (Statutory Rules and Orders, 1918, No. 1605), as being sufficient for the purpose.

A copy of the sealed Order and of the sealed 6-inch scale map referred to therein has been deposited for public inspection for the period of thirty days from the date hereof at the office of the Clerk to the Essex County Council, Shire Hall, Chelmsford, and a further sealed copy of the Order and of a 1-inch copy of the relative map has been deposited with the Clerk to the Braintree Urban District Council, Braintree, Essex.

INCOME TAX.

PAIGNTON URBAN DISTRICT COUNCIL.

PAIGNTON PAVILION PIER.

NOTICE is hereby given, that the above-named Council intend to make application to the Ministry of Transport for a Provisional Order for the following objects:—

(a) Power to purchase the lands, premises and undertaking known as the Paignton Pavilion Pier, situate in the Parish and Urban District of Paignton.

(b) Power to partially repeal the Paignton Pier Act, 1874.

(c) Power to levy tolls, rates or duties.

(d) Power to maintain and extend the Paignton Pavilion Pier.

(e) Power to dredge and to purchase dredgers, &c.

(f) Power to construct and maintain concert halls, baths, &c., on the said Pier.

(g) Power to let or lease concert halls on the said Pier, and to provide entertainments therein.
