

## GAS REGULATION ACT, 1920.

Notice of Application by the Falmouth Gas Company for an Order under Section 1 of the Gas Regulation Act, 1920.

**N**OTICE is hereby given, that the Falmouth Gas Company (hereinafter referred to as "the Undertakers") have applied to the Board of Trade, under the provisions of Section 1 of the Gas Regulation Act, 1920, for an Order providing for

(a) the repeal of any enactments or other provisions requiring the Undertakers to supply gas of any particular illuminating value, and the substitution therefor of power to charge for thermal units supplied in the form of gas; and

(b) the modification of the statutory or other provisions affecting the charges which may be made by the Undertakers by substituting for the standard price per 1,000 cubic feet now authorized, with an addition to meet increases in the costs and charges of and incidental to the production and supply of gas by the Undertakers since 30th June, 1914, a standard price per therm (i.e., 100,000 British thermal units).

The standard price now authorized in respect of the supply of gas by the Undertakers is 4s. (four shillings) per 1,000 cubic feet, and the price which the Undertakers have asked the Board of Trade to substitute for this price, in accordance with paragraph (b) above, is 1s. 9d. (one shilling and ninepence) per therm.

Notice of Application by the Eastbourne Gas Company for an Order under Section 1 of the Gas Regulation Act, 1920.

**N**OTICE is hereby given, that the Eastbourne Gas Company (hereinafter referred to as "the Undertakers") have applied to the Board of Trade under the provisions of Section 1 of the Gas Regulation Act, 1920, for an Order providing for

(a) the repeal of any enactments or other provisions requiring the Undertakers to supply gas of any particular illuminating value and the substitution therefor of power to charge for thermal units supplied in the form of gas; and

(b) the modification of the statutory or other provisions affecting the charges which may be made by the Undertakers by substituting for the standard price per 1,000 cubic feet now authorized, with an addition to meet increases in the costs and charges of and incidental to the production and supply of gas by the Undertakers since 30th June, 1914, a standard price per therm (i.e., 100,000 British thermal units).

The standard price now authorized in respect of the supply of gas by the Undertakers is four shillings and fourpence per 1,000 cubic feet within the town and parish of Eastbourne and the parishes of Willingdon, Westham and Pevensy, all in the county of Sussex, with an addition to such standard price of fivepence per 1,000 cubic feet within the parishes of Arlington, Hailsham, Hellingly and so much of the parish of Hurstmonceux as is not included within the limits of supply of the Bexhill Water and Gas Company as defined by the Bexhill Water and Gas Act, 1904, and the price which the Undertakers have asked the Board of Trade to substitute for this price, in accordance with paragraph (b) above, is 20.6 pence per therm within the said town and parish of Eastbourne and the said parishes of Willingdon, Westham and Pevensy, with an addition thereto of one penny per therm within the said parishes of Arlington, Hailsham, Hellingly, and so much of the parish of Hurstmonceux as aforesaid.
