The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:-

 ${\it Extension}$ of ${\it Scheduled \, District}$.

1. The Wiltshire and District (Muzzling and Control of Dogs) Order of 1920 shall be read and have effect as if the Area described in the Schedule hereto were included in, and formed part of, the Scheduled District described in the Schedule to that Order.

Commencement.

2. This Order shall take immediate effect: Provided that until the thirtieth day of November, nineteen hundred and twenty, a dog in or on any public place in the area described in the Schedule hereto need not be muzzled if it is led by a person with a collar and chain or other attachment.
