*In the administrative county of Gloucester:*

The parishes of Bromsberrow, Dymock, Kempley, Newent, Oxenhall, Pauntley, Taynton and Upleadon; and

*In the administrative county of Worcester:*

The parishes of Knightwick, Lulsley, Suckley, Alfrick, Leigh, Malvern Link, West Malvern, Great Malvern, Malvern Wells, Little Malvern, Welland, Castlemorton, Birtsmorton, Berrow, Eldersfield, Redmarley d'Abitot and Staunton, and the detached portion of the parish of Pendock.

ORDER OF THE MINISTER OF  
AGRICULTURE AND FISHERIES.

(DATED 13TH DECEMBER 1920.)

SUFFOLK (FOOT-AND-MOUTH  
DISEASE) ORDER OF 1920 (No. 7).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1.—(1) The Area described in the Second Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(2) Part III of that Order is hereby applied to such parts of the Scheduled District, which is described in the First Schedule hereto, and which includes the said Prohibited Area, as are not within the Prohibited Area.

(3) The provisions of Article 2 of the Suffolk (Foot-and-Mouth Disease) Order of 1920 shall continue to apply to the Prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.

2. This Order shall come into operation on the fifteenth day of December, nineteen hundred and twenty.

3. This Order may be cited as the SUFFOLK (FOOT-AND-MOUTH DISEASE) ORDER OF 1920 (No. 7), and shall be read with the Suffolk (Foot-and-Mouth Disease) Order of 1920 and the Suffolk (Foot-and-Mouth Disease) Orders of 1920 (Nos. 3 and 4).

FIRST SCHEDULE.

*Scheduled District to which restrictions apply.*

An Area in the administrative county of East Suffolk, comprising the parishes of Clopton, Debach, Dallinghoo, Dallinghoo Wield, Pettistree, Ufford, Gredfield, Boulge, Burgh, Grundisburgh, Culphe, Tuddenhams, Rushmere St. Andrew, Playford, Little Bealings, Great Bealings, Hasketon, Melton, Bromeswell, Eyke, Sutton, Woodbridge, Martlesham, Kesgrave, Purdis Farm, Foxhall, Brightwell, Waldringfield, Shottisham, Ramsholt, Hemley, Newbourn, Bucklesham, Alresbourn Priory, Nacton, Levington, Stratton Hall, Trimley St. Martin, Trimley St. Mary, Falkenham, Felixstowe and Kirton.

SECOND SCHEDULE.

*Prohibited Area.*

An Area in the administrative county of East Suffolk, comprising such parts of the parishes of Martlesham, Brightwell, and Waldringfield as lie within the following boundary, namely: Commencing at the confluence of the Martlesham Creek with the River Deben, and proceeding along the Martlesham Creek to Martlesham Bridge, thence in a southerly direction along the road from Martlesham Bridge via Mill Cottages and Martlesham Heath to a point about 70 yards north of the junction of that road with the road from Foxhall, thence in easterly, northerly, northeasterly, and easterly directions along the road and continuing track and road leading from that point via the north side of Foxburrow Plantation, the Folly, and Waldringfield Village, to the River Deben, and thence along that river to the point of commencement.
