ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 23RD DECEMBER 1920.)

HEREFORD (FOOT-AND-MOUTH DISEASE) ORDER OF 1920 (No. 4).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1.—(1) The Areas described in the Schedule hereto are hereby declared to be Prohibited Areas for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(2) Part III of that Order is hereby applied to such parts of the Scheduled District which includes the said Prohibited Area as are not within a Prohibited Area.

(3) The provisions of Article 2 of the Hereford (Foot-and-Mouth Disease) Order of 1920 shall continue to apply to the Prohibited Areas and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.

2.—This Order shall come into operation on the twenty-sixth day of December, nineteen hundred and twenty.

3.—This Order may be cited as the Hereford (Foot-and-Mouth Disease) Order of 1920 (No. 4), and shall be read with the Hereford (Foot-and-Mouth Disease) Order of 1920 and the Hereford (Foot-and-Mouth Disease) Orders of 1920 (Nos. 2 and 3).

The petty sessional division of Ledbury (except the parish of Mathon) and the parishes of Westhide, Withington, Weston Beggard, Bartestree, Lugwardine, Dormington, Stoke Edith, Mordiford, Hampton Bishop, Lower Bullingham, Dinedor, Holme Lacy, Bolstone, and Fownhope, and the parish of Preston transferred by agreement from the County of Gloucester, and

In the administrative county of Gloucester:

The parishes of Broomsberrow, Dymock, and Kempsey.

2. An Area comprising:—

In the administrative county of Gloucester:

The petty sessional division of Gloucester (except the parishes of Brookthorpe and Harescombe), and the parishes of Staverton, Up Hatherley, Shurdington, Badgeworth, Great Witcombe, Tibberton, Highleadon, Upleadon, and Corse, and

In the administrative county of Worcester:

The parish of Staunton,

and also comprising

The city and county borough of Gloucester.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 23RD DECEMBER 1920.)

SHREWSBURY AND DISTRICT (FOOT-AND-MOUTH DISEASE) ORDER OF 1920. (No. 3).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1914, and of every other power enabling him in this behalf, hereby orders as follows:—

1.—(1) The Area described in the Schedule hereto is hereby declared to be a Prohibited Area for the purposes of the Foot-and-Mouth Disease (Control of Movement) Order of 1920, hereinafter referred to as the "principal Order."

(2) Part III of that Order is hereby applied to such parts of the Scheduled District which includes the said Prohibited Area, as are not within the Prohibited Area.

(3) The provisions of Article 2 of the Shrewsbury and District (Foot-and-Mouth Disease) Order of 1920 shall continue to apply to the prohibited Area, and the provisions of Article 6 of the "principal Order" shall be read and have effect subject to this modification.

2. This Order shall come into operation on the twenty-sixth day of December, nineteen hundred and twenty.

3. This Order may be cited as the Shrewsbury and District (Foot-and-Mouth Disease) Order of 1920 (No. 3), and shall be read with the Shrewsbury and District (Foot-and-Mouth Disease) Order of 1920, and the Shrewsbury and District (Foot-and-Mouth Disease) Order of 1920 (No. 2).
